Privatized in 1992, it was acquired by the Dutch-based Aegon group, becoming a key player in the Hungarian insurance market under the names ÁB-AEGON and later Aegon Hungary.

In 2020, Aegon NV sold some of its Eastern and Central European interests to the Austrian-based VIG group, a prominent player in the Hungarian market through Union Biztosító. The Hungarian subsidiary, a successful company in the domestic market, joined VIG, with the Hungarian State as a minority owner.
